

# **COURSE SYLLABUS**

## Course: FINN 3623 Risk Management

## **Course Content:**

An analysis of the extent and types of risk in business; dealing with business risk; use of security and commodity exchanges; survey of insurance for risk bearing purposes; financial risk assessment and solutions; overall introduction of the concept of "Enterprise Risk Management"

## **Class Procedures:**

Lectures will be based on major points from the text and on current topics. Students are encouraged to participate and initiate classroom discussion. Exams will consist of both objective and subjective questions. There will be a required term paper/project.
