The pre-business GPA is not used to meet any UA requirements.

*Students pursuing a major or minor in accounting or finance must complete ACCT 2023.

At least 50% of business and economics must be taken in residence at University of Arkansas. For graduation, students must earn a 2.00 cumulative GPA in each of the following areas: all work completed at University of Arkansas, courses specifically designed for the major, and all required business core and economics courses. At least 30 hours of 3000/4000 level classes including major specific classes and SEVI 3013 must be taken at the University of Arkansas.
